






What is Scabies?

- Typically presents as an itchy rash
- Caused by a tiny parasite which burrows under the skin.
- Symptoms are a result of the body's immune system response to the mite's saliva, eggs and waste products.
- Itching is often worse at night.
- It is difficult to recognise and often attributed to other skin conditions leading to avoidable transmission.







Scabies facts



A person can get scabies from close physical contact with someone with scabies, e.g. holding hands (approximately 10 minutes).



Mites can live away from a host for up to 4 days, but the role of bedding, clothing and towels is unclear.



Incubation period is 3-6 weeks in a person who has never had scabies or 1-4 days if a person has previously had scabies.



Two forms of scabies caused by the same mite – 'classical scabies' and 'crusted scabies (formerly known as Norwegian)





Classical Scabies

- Most common form of scabies
- Generally, involves fewer mites (less than 20)





Crusted Scabies

- Uncommon
- Much more severe
- 1,000's or 1,000,000's of mites
- Highly contagious
- Presents as thick, crusty, scaly patches, often misdiagnosed as psoriasis or eczema (may not be itchy)
- Often seen in people with low immunity









Scabies treatment



- 2 full body applications of Lyclear Dermal (Permethrin 5%)
- Treatments should be applied 1 week apart.
- Adults (cases and contacts) usually need 4-6 x 30mg tubes for the 2 treatment applications. Insufficient lotion is a contributory factor to treatment failure
- After applying the treatment, residents/service users must wear clean clothing and get into clean bedding





- Application is best done in the evening and applied to cool dry skin - it is not recommended to have a hot shower or bath prior to application
- Wash hands and apply disposable apron and gloves
- Remove service users clothing and jewellery
- Treatment needs to be applied to the whole body, taking care to get it in all external creases of the body, such as nipples, genitals and buttocks
- Allow the cream to dry before dressing the service user in clean clothes/clean bedding
- Apply to the soles of the feet last after the body treatment has dried





Treatment Application

- Leave the cream or lotion for 8-12hrs (overnight will help ensure this)
- Do not bath/shower during this time
- Re-apply treatment to any areas of the body that is washed during treatment time – hands, genitals etc
- Remove PPE and wash hands
- Document treatment in the persons notes







Management of Scabies in health and social care settings

Single case

- Refer to GP for assessment and treatment
- Identify close contacts (including visitors within the 8 weeks prior to diagnosis)
- Contacts are defined as anyone who has close physical contact without gloves.
- All contacts should be treated at the same time as the case, 2 treatments, 1 week apart even if asymptomatic
- Observe other service users/staff for symptoms
- Disposable gloves and apron for all contact
- Avoid transfer to other settings during treatment





Management of Scabies in health and social care settings

Outbreak - 2 or more linked cases within an 8-week period

Close contacts should be identified and may include:

- All residents of the setting
- Residents on a single affected floor or wing if there is no mixing or movement of staff or residents and between floors or wings
- All members of staff (including agency staff) exposed to the index case without wearing PPE
- Visitors to the setting who have had prolonged or frequent skin-to-skin contact with a case
- Ancillary staff hairdressers, podiatrists, community health professionals and agency staff
- It is recommended that all contacts receive treatment at the same time as cases. It is the responsibility of the setting or management team to ensure that this is coordinated as much as possible within 24hrs of each other





Resident management

- Precautions: Standard infection control precautions, avoid skin-to- skin contact until 24 hours following completion of first treatment.
- Additional precautions for Crusted scabies: Long sleeved gowns, isolate in single room until 1st treatment completed. Increase frequency of vacuuming and deep clean after each treatment.







- Linen, clothing and washable footwear including slippers should be washed separately at a minimum 50°C, and tumble dried
- Thermal disinfection at 71°C for 3 minutes or 65°C for 10 minutes is advised
- Any items which cannot be laundered in a hot wash can be placed in a sealed plastic bag for at least 4 days prior to laundering: this should be sufficient to kill any mites present.









Environmental Cleaning

Scabies mites live on and under the skin. They can possibly survive off the body for up to 4 days, but whether this is linked to transmission is not known.

- Routine cleaning of hard surfaces in the environment with warm water and general-purpose neutral detergent is sufficient.
- Soft furnishings with non-wipeable covers should be removed from use following treatment and placed into plastic bags and sealed for 4 full days, to allow any mites on the fabric to die. The items should then be vacuumed.
- For crusted scabies, increase the frequency of vacuuming and deep clean after completion of treatment

Scabies treatments for residents

Treatment is usually arranged via the GP practice that has overall responsibility for the residents of the care home

Recent supply issues have presented challenges in securing adequate supplies of permethrin cream but these seem largely to have resolved

Ivermectin is an oral treatment option that may be indicated in some resistant cases or where topical therapy is contraindicated/not appropriate



Scabies treatments for staff

States.....

Where occupational exposure of staff has led to their need for treatment, it is recommended that the employer should consider funding any treatment rather than staff paying for their own prescriptions. This encourages treatment uptake and promotes a prompt return to normal working. Social care settings can consider discussing alternative funding options with local authority public health or social care commissioning teams.

GP practices are not responsible for overseeing treatment for staff

Occupational arrangements apply - usually treatments are sourced via a local community pharmacy






Community Infection Prevention and Control Policies for Domiciliary Care staff






Preventing Infection Workbook: Guidance for Domiciliary Care staff 3rd Edition

Changes to the Self Advocacy Service

Care Connected 7th August 2024





Self-advocacy is about gaining the knowledge, learning the skills and developing the confidence to communicate what's important to you.

Having the confidence to speak up about the things you care about and the decisions that affect you allows you not just to challenge those decisions but also to shape and codesign things such as the services you might use.

How has this worked in North Yorkshire

Since 2012, a charity, Keyring, has supported people with a learning disability and/or autistic people in North Yorkshire to speak out about things that are important to them and make changes happen, with funding from North Yorkshire Council Health and Adult Services

What is changing

At the end of September, the contract with Keyring is coming to an end.

This is an opportunity to look at how more people who access Health and Adult Services and their families and carers can be actively involved in the Directorate's work, co-design services and be supported to have the skills and confidence to challenge and hold decision makers to account, and ultimately work better together. Between September and November, the HAS Involvement Team will be going out to speak to as many people as possible about how they want to be involved in the work of Health and Adult Services (if at all!), what self-advocacy means to them and what people need to have their voices heard.

We would also like to hear the views of HAS Staff and Care Providers to understand some of the barriers that prevent people from having their voices heard and hear ideas on where we can improve.

What about self-advocates who are already members of groups?

We appreciate, that for many of our existing self-advocates, their monthly meetings with Keyring are a lifeline, something they look forward to and a place to see friends and socialise. Therefore, wherever possible, we will be using existing meeting dates to work with self-advocates to start to think about what they would like their groups to look like moving forward, how these run and what their main areas of focus are.





What about the North Yorkshire Learning Disability Partnership Board?

The current Learning Disability Partnership Board members will be meeting later in the year to focus some time on looking at the future of the Board and how they would like this to work moving forward. At present Board meetings will continue as normal and support will be provided by the Involvement Team to ensure everyone has what they need to attend meetings.






Ideas from Selby area:

- Working with NYC and the care sector to inform and influence government and ensure that social care remains at the forefront of public debate.
- Ensuring the care sector is adequately represented on all appropriate statutory groups and bodies, including joint work with the Council and the NHS.
- Creating and supporting the formation of local provider meetings across the County.
- Providing an additional channel of communication to help improve the flow of information between statutory agencies and the care industry in North Yorkshire.
- Assisting in the identification and research of national policy and emerging good practice and disseminating this to the care industry in North Yorkshire.
- Engaging with the Council and supporting its workforce development plans and initiatives in respect of the wider care market workforce in North Yorkshire as well as engaging in partnership work with the Council and the NHS (ICB).

On 23/07/2024 this procurement went live on the Yortender Portal (<u>Public quote/tender -</u> <u>Representative Body for Adult Social Care (eu-supply.com</u>) and will remain open for 30 days for any interested bodies to submit an application. Once awarded the selected body would remain the recognised body for 3 years after which a new procurement would be undertaken.
