RAISING AN ADULT SAFEGUARDING CONCERN

- 1. If you suspect criminality or believe the individual to be at immediate risk of harm dial 999.
- 2. If the situation is not deemed urgent, please submit a written adult safeguarding concern form via the relevant electronic portal, which can be found on the websites above.
- 3. If you believe the situation is **urgent** but does not require the police, contact Adult Social Care on the relevant telephone number above. Give all details/information and confirm that you are raising an adult safeguarding concern. You must follow a verbal referral up in writing within 24 hours.
- 4. Please download a copy of the safeguarding concern form you have submitted to be added to the patient's electronic health records. Please ensure this is hidden from online view.
- 5. You will receive acknowledgement of your contact being received. Should you not receive this please follow up to ensure your information has been received.
- 6. Always follow Safeguarding Adult Policies and Procedures.
